

Discovering the Ideal Nonprofit Grants:

Strategies for Grant Research

Nonprofit grants provide valuable funding opportunities, but finding and securing the right ones requires thorough research. Here are some strategies to help you kickstart your grant research and obtain the resources your nonprofit needs to succeed.

1. Identify the Type of Grants You Need

Begin by reviewing your budget and assessing your organization's most urgent needs. Consider whether you're looking to fund a specific project or if you need cash or in-kind support. Create a list of areas and projects that a grant could help with, prioritizing the most critical ones.

Next, explore the following types of grants to find the best fit for your nonprofit:

- Program Grants: These funds are designated for specific projects or programs. For example, you might seek a grant to launch a free after-school program for at-risk youth.
- **Technology Grants:** Some grants are aimed at enhancing your nonprofit's technological capabilities. You could use these funds for donor management software or virtual event platforms.
- **In-Kind Grants:** These grants provide non-monetary support, such as office supplies, construction services, advertising space, or legal advice.
- Capital Grants: If your nonprofit is launching a capital campaign to purchase property, build a facility, or create infrastructure for community service, consider seeking capital grants.

Grants are typically offered by three main types of funders: government agencies, foundations, and corporations. When researching government grants, ensure they are federal or state-based, as eligibility varies. Foundations and corporations also have specific restrictions, so carefully review the requirements for each.

2. Utilize Online Grant Databases

For grantmakers, sharing funding opportunities is an essential part of the grant lifecycle. Online grant databases like Grants.gov and GrantStation are valuable resources for



nonprofits. Once you know what you're looking for, search these databases for a variety of available opportunities.

To streamline your search, use filters to narrow down results by:

- Type of grant
- Eligible organization types
- Cause areas
- Location
- Application deadlines

Use relevant keywords to find grants that align with your mission. For example, if your cat rescue organization is seeking technology funding, try searching for terms like "technology funding," "animal shelter grants," or "cat nonprofits."

3. Document Eligibility Requirements

Once you've identified several relevant grant opportunities, take the time to review their application requirements. This will help you avoid spending time on grants for which you may not qualify.

Keep detailed notes on the rules and criteria for each grant, including:

- Eligible Organizations and Causes: Most grantmakers require organizations to be registered 501(c)(3)s, and some grants may limit eligibility by specific causes.
- **Application Requirements and Deadlines:** Allow sufficient time for writing and finalizing a grant proposal—typically at least two weeks.
- **Grant Restrictions:** Understand the limitations on fund usage to ensure they align with your needs.
- Recordkeeping and Reporting: Each grant will have specific requirements for tracking and reporting how funds are used.

Many grantmakers use specialized software for managing applications, which may require an eligibility quiz before applying.



4. Focus on Grants That Align With Your Mission

Just as sponsors seek relevance to your nonprofit's cause, grantmakers prefer to support organizations that share their goals. Therefore, prioritize grants and grantmakers that align closely with your mission.

For example, while a water conservation organization can apply for general environmental grants, it should prioritize grants specifically focused on clean water or ocean conservation, where it has a stronger chance of success.

Research past grantmaking activities and recipients to identify those who have supported similar organizations or projects.
